FROM the DESK of the RIPLEY TOWN HISTORIAN

Open letter to the Ripley community from the Ripley Town Historian:

This may seem like an odd request, but I am researching an event that took place here in Ripley on June 3, 1825. It is the very day that General Lafayette entered Chautauqua County at State Line and toured this region as he traveled on his Farewell Tour through New York State. There is a certain newspaper article that was published on June 8, 1825 in the Fredonia Censor. It describes that whole event.

In order for the town to be eligible for an historical marker for this event, I need a copy of this article. Believe me when I say this, I have had a number of others searching for this article with no luck. So, just in case you have an old family bible or scrapbook that just might have this, PLEASE let me know!!! That would make my day



for sure!!! Trust me when I say this, I have done enough research on a number of topics, and I have run across items from this era. If you have this item, please contact me at hamels@fairpoint.net.

A Message from your Town Supervisor, Lauree Pless

First and foremost, I would like to sincerely thank all of the residents that supported my candidacy during the November election. I am excited to continue serving as your Town Supervisor for the next three years. I would also like to wish everyone a happy and healthy holiday season. The holidays always bring bittersweet emotions as we celebrate with friends and family while also reflecting on the memories we have with those that are no longer with us. We are certainly fortunate to have a community that makes great efforts to look out for each other and support each other during difficult times. For those of you who may be struggling, I hope you find comfort in knowing that you are being thought of throughout the season.

Shovel Ready Site Updates

The shovel ready site is still on track to being breaking ground in the Spring of 2025. In late October, National Grid, The Industrial Development Agency and I met with property owners that are potentially impacted by the electrical upgrades needed to complete the project. The meeting was very well attended and the discussion was very productive.

ONVO Travel Center on Shortman Road

The plan to develop a travel plaza at the spot where the Lion's Den is currently located is still on track to begin in the Fall of 2025. We continue to work closely with ONVO as well as local agencies and County agencies in an effort to keep the process moving forward.

Zoning Grant update

The town is still waiting to find out if we will be awarded the grant funds from the State to conduct a zoning study for the town. The zoning study will help us determine if our current zoning maps need to be updated or modified to better serve our residents and businesses in the area or looking to expand to our area. We hope to be notified as to whether or not we will be awarded these funds by the end of this year.


