60th Anniversary of Fire that Destroyed Ripley



When you drive down Main Street in Ripley, there isn't much there. It seems the town never recovered from the devastating New Year's Day fire that took out most of the business district in 1965.

An eye-witness account of that day was published in the Jamestown Post-Journal on the 30th anniversary of that date, and parts of it will be repeated here.

Most of those of us older than sixty can remember Ripley as it was. Main Street boasted three grocery stores, an appliance store, a small theater, and a print shop. Everything from O'Donnell's Bar to the east, (now Cooney Island Ice Cream and Coffee on Main), to the American Legion Hall (since torn down) to the west, was wiped out.

Shovel Ready Site Updates

The shovel ready site is still on track to break ground in the Spring of 2025. Members of the Town, the Industrial Development Agency and County representatives continue to meet monthly to review any updates and provide input into the process and plans for the development of the site.

The Ripley Fire of New Years Day, 1965

Excerpts from Jamestown Post-Journal article written by David Hawker:

“The full wail of the siren startled me from sleep. The night was still in full darkness. I got up and went across the hall and before I turned the light on, the room was lit by a frightening orange glow coming through the rough glass of the window facing east toward town!

I ran to the living room to the big picture window. My freshly-awakened gaze was met by a huge pillar of orange smoke rising from somewhere in town.

The next vivid recollection is of running as fast as I could across the tracks and down Maple Avenue to Main Street. At the corner of Maple and Main I saw the first fire trucks arriving at the scene. I could now see that they were at a place somewhere right in town and the long, orange pillar bent to the southeast was growing with intensity.

The whole rear of the Hepco building was in full flame, although the fire had not yet made its way, visibly, to the front of the store. The fire hoses were lying on the wet road like dark veins, the orange glow intensifying their outlines.

The television sets exploded in blue flames, and the collapse of the interior and then the whole front wall falling into the street, with a huge fireball rising into the orange smoke, was a great shock.

A fatal lack of water pressure made the fight to save the town a vain but valiant effort.

The little alley between the Hepco building and the building which had been Mrs. Patterson's store didn't stop the flames.

The heat and dry wooden window frames were a fatal combination. The fire spread west, engulfing the Patterson store, then the old Red and White building. All were lost.

Steve's Market was next door to the Hepco building to the east. It was clear that the wood-framed building was in danger of consumption. I was among those who took part in clearing stock from the store. All the groceries, cans and so forth were piled on the steps of O'Donnell's Hotel.

Inside was chaotic. One chap had fallen flat on his back on the cans that were everywhere on the floor between the shelves. He got back on his feet and continued to scoop up the stock from the shelves.

The cracks in the back wall were clearly aglow as the fire had already begun to involve the house-like store—the final victim of that night.

A lone box of Mr. Bubble bath soap with its smiling face, sat on a top shelf otherwise completely empty.

At one point the fire hoses had to be turned onto the store across the street, the delicatessen owned by Loretta McNeil. The heat was so intense the red paint on the storefront had begun to blister. The big window, which at that time filled most of the front of the building, was found to be slightly warped from that time on.

All of this happened within a very few hours. I was only 17 years old, and the feeling I felt as a witness to that event was grief. A major part of my town was lost so effortlessly.

Arriving back at the scene later that day was a somber affair. The gaping debris-filled basements, the empty, broken walls, that smell, the panel truck that had been in the basement garage of the Hepco building, blackened and almost flat from the collapsing walls - all of it still there, entombed beneath the parking lot. It is something that those of us who were here then will never forget.”

David Hawker, author of the article above, holds a panoramic photo he took of the fire’s devastation on that day. The stores between O’Donnell’s Hotel and the American Legion Hall (not shown) were all destroyed.

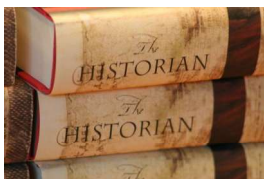

FARMLAND PROTECTION PLAN

RESOLUTION # 80-2024 TOWN OF RIPLEY

ADOPTION OF THE TOWN OF RIPLEY AGRICULTURAL AND FARMLAND PROTECTION PLAN

Whereas, the Town of Ripley applied for and received funding from the New York State Department of Agriculture and Markets to develop an Agricultural and Farmland Protection Plan to provide guidance, policies, and actions for the protection of and continued opportunities to promote agriculture in Ripley; and

Whereas, a dedicated Steering Committee was formed to work with planning consultants in which multiple meetings and workshops were held with the farming community as well as a general public meeting to gather input; and

Whereas, a draft plan was developed and refined with insight from the Committee, the State Department of Agriculture and Markets, Chautauqua County Planning and Development, and other entities; and

Whereas, the Town referred the draft plan to Chautauqua County Planning and Development and the Agricultural and Farmland Protection Board, which formally approved of the plan on September 30, 2024 as required by Agriculture and Markets Law 25AAA Section 324-A; and

Whereas, a public hearing was scheduled and held for this date (December 12, 2024), in which the Town Clerk advertised the hearing and made the draft accessible via the Town's official website; and

Whereas, in accordance with the provisions of 6 NYCRR Part 617 (SEQRA), the Town Board determines that the Proposed Action is subject to SEQRA and makes a preliminary classification of such as an Unlisted Action followed by the preparation of a Short Environmental Assessment Form (EAF).

Now, Therefore be it Resolved, that the Town Board hereby designates itself as the Lead Agency for the Unlisted Action pursuant to 6 NYCRR Part 617.

Further Resolved, that the Town Board has examined the EAF, caused to be prepared Parts 2 and 3 of the EAF to evaluate the Proposed Action in accordance with determination criteria under 6 NYCRR 617.7(c), and determines that the Proposed Action would not result in any significant adverse environmental impact, resulting in a *Negative Declaration* determination.

Further Resolved, that the Town Board hereby adopts in its entirety the Town of Ripley Agricultural and Farmland Protection Plan as final and shall submit the document to the State Department of Agriculture and Markets for Commissioner approval.

INTENT TO ACT AS LEAD AGENCY UNDER SEQRA FOR LOVE'S RV PROJECT

WHEREAS, the Town of Ripley Town Board ("Town Board") has received an application from Love's Travel Stops and Country Stores, Inc. ("Love's") for a special use permit and site plan approval for the addition of 3 RV overnight spaces.

WHEREAS, the Project site is composed of tax parcel number involving tax map ID No. 240.00-3-2.2, located at 6151 Shortman Road in the Town of Ripley, Chautauqua County, New York; and

WHEREAS, the Town Board has determined that the application is subject to SEQRA and

WHEREAS, the application was accompanied by Part 1 of a Short Environmental Assessment Form ("SEAF") dated December 4, 2024; and

WHEREAS, after reviewing the EAF, the Town Board has determined that the Project is an Unlisted Action pursuant to 6 NYCRR Part 617.4 and

NOW, THEREFORE, BE IT RESOLVED THAT,

Section 1. Pursuant to, and in accordance with, the provisions of Section 617.6 of the New York State Environmental Quality Review Regulations (6 NYCRR Part 617) the Town Board of the Town of Ripley hereby makes the following determinations and classifications with respect to the review of the attached Special Use Permit Application and Site Plan Review,

A. The Town Board of the Town of Ripley hereby determines that the action is subject to SEQR.

B. The Town Board hereby determines that the action does involve other agencies.

C. The Town Board hereby makes a preliminary classification of the action as an unlisted action.

D. The Town Board hereby determines that it is, and will be, the lead agency with respect to said Project.

E. The Town Board hereby approves the Short EAF attached here to.

Section 2. A public hearing on the Proposed Special Use Permit application and Site Plan Review will be held on 1/9/25 at 6:15 p.m. in the Ripley Town Hall, 14 N. State Street. The Town Clerk is hereby authorized to publish notice of the said public hearing in the

Jamestown Post Journal, the official newspaper of the Town, and to give notice thereof to the Chautauqua County Department of Planning and to other municipalities, boards and agencies entitled to notice thereof.

Section 3. A copy of this resolution shall be sent by the Town Clerk to the Town of Ripley Planning Board, the Town of Ripley Zoning Board of Appeals, the Building and Code Inspector of the Town, Chautauqua County Planning Department, and the Commissioner of Environmental Conservation of the State of New York.

Section 4. This Resolution shall take effect immediately.
